In order to contact you more efficiently we may, at times, contact you using autodialed or prerecorded message calls or text messages at the telephone number(s) you have provided us or we have received from your creditor, which you have expressly provided to them. We may place such calls or texts to (i) collect a debt owed to a creditor, (ii) provide notices regarding your account or account activity, or (iii) investigate or prevent fraud.

You agree that we and our service providers may contact you using an automatic dialing system, pre-recorded messages, and SMS/text messages for the purposes we have identified above. We may share your phone number(s) with service providers with whom we contract to assist us in pursuing these interests but will not share your phone number(s) with third parties for their own purposes without your consent. Standard telephone minute and text charges may apply. We and our service providers will not use autodialed or prerecorded messages or texts to contact you for marketing purposes at the telephone number(s) you designate unless we receive your prior express written consent.

If you provide an e-mail address to The Stark Agency, or any employee of The Stark Agency, you are giving The Stark Agency express permission to contact you at the e-mail address provided. You may choose to revoke consent to receive e-mails, phone calls or text messages by contacting us at 1-877-274-7764 or by emailing us at help@starkforyou.com.
